IN pursuance of the provisions of clause (3) of Article 348 of the Constitution of India, the Governor is pleased to order the publication of the following English translation of notification no. 2543/IX-1-2020-33T.A.-20, dated December 20, 2020 :

No. 2543/IX-1-2020-33T.A.-20

Dated Lucknow, December 20, 2020

WHEREAS notification no.1483/IX-1-2020-33T.A.-20, dated November 20, 2020 was issued and published in the *Gazette* on the same date with a view to invite objections and suggestions for general public with respect to the inclusion of the areas specified in the Schedule below in the transitional area of Nagar Panchayat Tindwari in District Banda as required by section 4 of the Uttar Pradesh Municipalities Act, 1916 (U. P. Act no. II of 1916);

AND, WHEREAS, objections and suggestions received in pursuance of the said notification were disposed of *vide* Government order no. 2404/IX-1-2020-33T.A.-20, dated December 14, 2020;

NOW, THEREFORE, in exercise of the powers under clause (2) of Article 243-Q of the Constitution read with sub-section (2) of section 3 of the Uttar Pradesh Municipalities Act, 1916 (U. P. Act no. II of 1916), and in partial modification of notification no. 2207-T/IX-1-82-31-T-80, dated May 12, 1982 and other previous notifications issued in this behalf from time to time, the Governor is pleased to include the areas specified in the Schedule below in the transitional area of Nagar Panchayat Tindwari in District Banda for the purposes of Part IX-'A' of the Constitution.
